Isingeniso

Ngonyaka ka-2016 i-MTN Group Limited yenze i-MTN Zakhele Futhi (RF) Limited ("MTN Zakhele Futhi" noma "Inkampani"), indlela yabantu baseNingizimu Afrika abamnyama abakulungele ukutshala imali i-MTN Group Limited ("MTN Group" noma "MTN"), umhlinzeki wemisebenzi yase-telecom yezimakethe ezisafufusa ezhambha phambili.

I-MTN Zakhele Futhi cishe ino-4% wamasheya ku-MTN Group. Lokhu kutshalwa kwemali yimpahla kuphela yeNkampani. Inkampani futhi iphatha ukuxhasa ngemali okuhlanganisiwe kwalokhu kutshalwa kwemali - okuba ngamasheya akhethwayo abhaliselwe ngabahlinzeki besikweletu ongomunye umuntu kanye nendawo yezimali ekhishwa kuzwelonke ethathwe ku-MTN Group. U-80.5% wabanikazi bamasheya banengcosana yamasheya ajwayelekile kunama-500 okukhombisa isimo sesikimu esincike ngobubanzi kokuyiqiniso.

Ukusebenza kwezimali

Ukusebenza kwemali yeNkampani kuncike ngokuphelele enanini lentengo yesheya le-MTN Group kanye nanoma iyiphi inhlukaniselwana eshiwo netholakele kwa-MTN Group ngonyaka.

Ngomhla ka-31 Disemba 2018, iNkampani yabona ukulahlekelwa ngemuva kokukhokha intela eyizigidi eziwu-R325,8 (2017: izigidi eziwu-R201,1 eziyinzuvo evuselelw). Inzudo cishe ifakwa ngokuphelele ekutholeni izinhlukaniselwano ezivela ku-MTN Group ngonyaka. Ukulahleka kubangelwa ukuphinde kukalwe into yokusebenza yezimali ekhiphayo ekupheleni konyaka njengoba kudingwa yi-International Financial Reporting Standards. Ukulahleka ekuphindeni kukalwe kwento yokusebenza yezimali ekhiphayo kucishe kube ngenxa yokwehla kwenani lentengo yesheya le-MTN Group ukusuka ku-R136,60 ngomhla ka-31 Disemba 2017 ukuya ku-R89,00 ngomhla ka-31 Disemba 2018.

Ukwehla kwenani lentengo yesheya kusukela ngaphambi konyaka wezimali nakho kwaholela ukulahlekeni kwenanai elikahle lesigidi esiwu-R2 433,0 (2017: isigidi esiwu-533,1 senzuso) ebonakala kusitativimende semali engenayo ephelile.

Ukukhokha kokubuyisela isikweletu se-MTN Zakhele Futhi

Ngonyaka ka-2018, iNkampani yathola izigidi eziwu-R480,2 (2017: izigidi eziwu-537,8) eyimali engenayo eyinhlukaniselwano evela ku-MTN Group futhi yakwazi ukukhokha isikweletu esingaphezu kohlelo lokukhokha olubhajethelwe. Le mali engenayo yasetshenziswa kuqala ukukhokha izindleko zokusebenza ezivunyelwe zeNkampani kanye nentela enokusele kwemali engenayo eyinhlukaniselwano isetshenziselwe ukukhokha izinhlukaniselwano ezikweletwa kubanikazi bamasheya abakhethwayo kanye nokunciphisa ingxenye yemali yokwenza umsebenzi yesikweletwa abanikazi bamasheya abakhethwayo.

Izigidi eziwu-R313,0 zemali engenayo yenhlukaniselwano yasetshenziswa ekushesheni kubuyiselwe amasheya akhethiwe ngonyaka wezimali ka-2018. Lokho ekugcineni kuzoholela ekuncipheni kwezinhlukaniselwano ezikhokhwa kumasheya akhethwayo esikhathini sempilo yalezi zinto zokusebenza.

Ngonyaka ka-2017 u-MTN wathengisa u-549 974 wala Masheya Aqinisekisiwe ngokusebenzisa Umnikelo Omncane ohloselwe ikakhulukazi kulabo bafakizicelo ababefake izicelo zamashaya e-MTN Zakhele Futhi ngesikhathi somnikelo wokuqala futhi abawabelwanga wona ngempumelelo ngenxa yezizathu ezalhukene. Ukwengeza kuMnikelo Omncane, u-MTN wangena ezivumelwaneni zokuthengisa ezalhukene nabatshali zimali bezikhungo ezinkulu ukuthengisa isamba sika-9 088 320 ngonyaka ka-2017 saMasheya Aqinisekisiwe.

Amanye Amasheya Aqinisekisiwe awu-3 240 athengiselwa abahlanganyeli boMnikelo Omncane yi-MTN ngekwata yokuqala ka-2018 kwehlisa ukuphathwa kwe-MTN Group kwaMasheya Ajwayelekile e-MTN Zakhele aba ngamasheya ajwayelekile awu-18 277 026 ngomhla ka-31 Disemba 2018.

Ngesikhathi Sokutshala Imali Esiphansi okungukuthi kusukela ngomhla ka-24 Novemba 2016 ukuya kumhla ka24 Novemba 2019, abanikazi bamasheya abavumelekile ukuthengisa, ukudlulisa noma ngenye indlela ukulahla Amasheya abo Ajwayelekile e-MTN Zakhele Futhi. Ngomhla ka-25 Novemba 2019 Isikhathi Sokutshala Imali Esiphansi siyaphela futhi iNkampani seyiqale izinyathelo zokufaka ohlwini Amasheya Ajwayelekile e-MTN Zakhele Futhi ku-JSE ukuze kuqhutshwe ukuhweba phakathi kwabantu abamnyama abafanelekile kanye namaqembu amnyama ngesikhathi seminyaka emihlanu esele yeSikhathi Sokunikeza Amandla. Ukucabanga ngokufakwa ohlwini okuphakanyiswayo ku-JSE, kuzohlelwa imiboniso yokwazisa kwaziswe abanikazi bamasheya kusenesikhathi ngalokho kufakwa ohlwini okuphakanyiswayo ukuze kuhlinzekwe abanikazi bamasheya ngolwazi olumaqondana nezindlela zokuhweba kanye nezinhlelo.


